

ADDING A PARTY

Step 1 - Search for a party prior to adding.

Before adding a party, a search of the database for the party must be performed. A search may be performed by Social Security Number, Tax Identification Number, Last Name or Business Name.

To search by name, enter the last name or the first few characters of the last name to search. If this is a business filing, enter the first word or significant words of the name to search the database. The entire business name is stored in the Last/Business name field. The field size is 80 characters.

Search for a party

SSN Tax Id

Last/Business name

First Name

Middle Name

Enter the last name and click [Search].

Search Hints:

Enter one field of data for each search.

Format Social Security Number or Tax ID with hyphens.

Searching is case sensitive - use upper and lower case. Include punctuation. (O'Brien)

Try alternate search clues if your first search is not successful.

Partial names can be entered.

Wild cards (*) are not required at the end of search strings.

Step 2 - If there are no matches, the system will return a "No Person Found" message.
