

Link or Unlink a Filing Agent and Attorney/Trustee Account

To link a filing agent:

- 1. On the Court's Website <u>www.gamb.uscourts.gov</u>, click on the E-Filing (CM/ECF) link, then click on the **Live Document Filing System** to access CM/ECF.
- 2. Enter your PACER Username and Password. Client Code is not required.
- 3. Click Login.
